**TO THE HONORABLE, THE JUDGES OF THE UNITED STATES ARMY  
COURT OF CRIMINAL APPEALS**

COME NOW the undersigned appellate defense counsel, pursuant to Rules  
23 and 24 of this court's Rules of Appellate Procedure, and move this court to  
grant appellant's Motion for Extension of Time. The undersigned appellate  
defense counsel request a 15-day extension of time until 20 January 2022 to file a  
Reply Brief on Behalf of Appellant.

1. Consistent with Army Reg. 27-26, Rules of Professional Conduct  
for Lawyers, undersigned counsel request additional time to ensure  
that all due diligence has been done to adequately respond to the  
Government's Brief in this case and to fulfil counsel's ethical  
obligation to represent Appellant's interest.

2. The record of trial in this contested case is 1624 pages. The approved sentence was adjudged on 17 May 2017, and it includes a bad-conduct discharge and reduction to Private E-3. His sentence rehearing sentenced him to reduction to E-5. Appellant concurs with the request for an extension.

3. The current due date is 5 January 2022. Defense counsel requests additional time to review the record, research issues, and confer with appellant after the Government's Brief is received. Additionally, the first undersigned counsel is on leave from 17 December 2021-2 January 2022, along with many of the reviewing attorneys at Defense Appellate Division.

4. The first undersigned defense counsel has 20 cases pending at this court and 6 pending at the Court of Appeals for the Armed Forces. Undersigned counsel was assigned this case on 31 May 2021.

5. Counsel anticipate responding substantively.

WHEREFORE, appellate defense counsel respectfully request that this Court grant the instant motion.


