COME NOW the undersigned appellate defense counsel, pursuant to Rules 23 and 24 of this court's Rules of Appellate Procedure, and move for a seven (7) day extension of time to file appellant's reply brief. Appellant's reply brief is currently due on 29 November 2021. Should this court grant appellant's motion, the new suspense would be 6 December 2021.

As good cause for granting this extension, the undersigned counsel hereby affirm that:

- (1) On 22 November 2021, the government filed its Brief on Behalf of Appellee.

- (2) The trial was contested;
- (3) The trial transcript contains 1,412 pages. The complete electronic record of trial contains an additional 986 pages of allied documents, exhibits, and attachments.
- (4) The approved sentence, adjudged on 20 July 2020, included confinement for three years, reduction to the grade of E-1, and a bad-conduct discharge;
- (5) Appellant is currently in confinement;
- (6) Appellant consents to this request for an extension;
- (7) Undersigned counsel request a seven day extension to have an opportunity to review the government's brief and to craft any appropriate response.
- (8) Undersigned counsel believe that the requested extension is in the best interest of appellant and that denying this request will materially prejudice appellant's appellate rights.

WHEREFORE, the undersigned counsel respectfully request a seven-day extension of time to file appellant's reply brief, to 6 December 2021.


