COMES NOW the undersigned appellate defense counsel, pursuant to Rules
23 and 24 of this Court's Rules of Appellate Procedure, and move for a 30-day
extension **until 28 May 2022** to file appellant's brief. The brief is currently due 28
April 2022.

Consistent with Army Reg. 27-26, Rules of Professional Conduct for
Lawyers, undersigned counsel request additional time to ensure that all due
diligence has been done to adequately review, investigate, research, and brief the
assignments of error in this case and to fulfil counsel's ethical obligation to
represent appellant's interest.

The transcript in this contested case is 435 pages. The approved sentence
was adjudged on 12 February 2021, and it includes reduction to the grade of E-1,

confinement for four years and a discharge from the service with a dishonorable discharge. Appellant is still in confinement. He concurs with this request.

Civilian defense counsel requests additional time to review the record, research issues, and confer with appellant and detailed military defense counsel.

WHEREFORE, appellate defense counsel respectfully requests that this Court grant the instant motion.

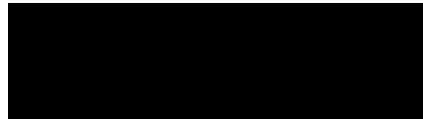

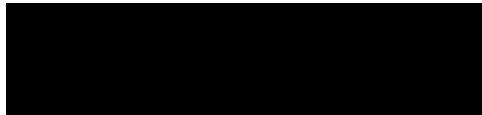
