TO THE HONORABLE, THE JUDGES OF THE
UNITED STATES ARMY COURT OF CRIMINAL APPEALS

COME NOW the undersigned appellate defense counsel, pursuant to Rules
23 and 24 of this court's Rules of Appellate Procedure, and move for a 30-day
extension of time until 29 November 2022 to file a Brief on Behalf of Appellant.

1. Consistent with Army Regulation 27-26, Rules of Professional
Conduct for Lawyers, the undersigned counsel request additional time
to ensure that counsel have diligently investigated, thoroughly
researched, and appropriately briefed the assignments of error in this
case in order to fulfill counsel's ethical obligation to represent the
appellant's interest.

2. This is a contested case with mixed findings and a conviction for
an Article 120, UCMJ offense. Appellant's case involves multiple co-
accused, to include at least one companion case that is currently
pending before this court. The record of trial with exhibits and allied
papers is approximately 1,250 pages, which includes 742 pages of
trial transcript. The sentence adjudged on 3 February 2022 included
reduction to the grade of E-1, confinement for 24 months, and a
dishonorable discharge. Appellant is currently in confinement.
Appellant concurs with this request.

3. Appellant's brief is currently due on 30 October 2022. Appellant requests a 30-day extension of time to 29 November 2022.

4. First undersigned counsel is currently assigned 29 cases (22 contested) with approximately 16,000 transcript pages pending before this court and the Court of Appeals for the Armed Forces (CAAF). In the next thirty days, first undersigned counsel has five other initial briefs due to this court, and three supplements with assignments of error due to the CAAF.

5. The undersigned counsel request additional time to review the record, research issues, confer with appellant, and conduct supervisory review.

WHEREFORE, appellate defense counsel respectfully request that this court grant the instant motion.
