as counsel for the case listed above.

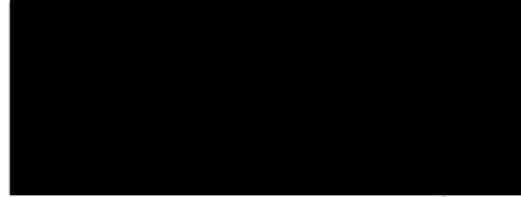
