WHEREFORE, appellate defense counsel respectfully request that this Court grant the instant motion.

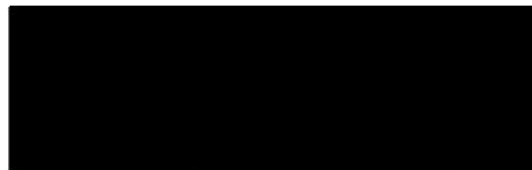
