COMES NOW the undersigned defense counsel, pursuant to Rules 9 and 12 of this Court's Rules of Appellate Procedure, and moves that this Court grant leave for Mr. Scott Hockenberry, Esq. to appear *pro hac vice* in this matter. Of note, as disclosed in Mr. Hockenberry's pending application for admission to the Court, while on active duty in the Army JAG Corps, Mr. Hockenberry's Staff Judge Advocate suspended his legal duties in accordance with the provisions of Army Regulation 27-1, paragraph 11-1 between 23 April 2019 and 5 September 2019 due to a [REDACTED]. Mr. Hockenberry's certification to practice pursuant to Article 27(b) was never suspended. Mr. Hockenberry has since been honorably discharged from the Army.

WHEREFORE, the undersigned requests that this Court grant the instant motion.
