Brigadier General LeAnne Pittman Burch was born and raised in Arkansas, and earned a Bachelor of Arts degree from Hendrix College in Conway, Arkansas in 1982. She attended law school at the University of Arkansas at Little Rock before earning a Juris Doctorate from Memphis State University in 1985. She holds a Master of Laws degree from The Judge Advocate General's Legal Center and School and a Master of Strategic Studies degree from the U.S. Army War College. Brigadier General Burch was directly commissioned into the Army Judge Advocate General's Corps in 1986.

Brigadier General Burch's active duty assignments include duty with the 8<sup>th</sup> Infantry Division (Mechanized) branch Office of the Staff Judge Advocate in Baumholder, Germany, the Office of the Staff Judge Advocate, III Corps and Fort Hood, in Fort Hood, Texas, and then assignment with the Womack Army Medical Center followed by assignment in the Office of the Staff Judge Advocate, XVIII Airborne Corps, at Fort Bragg, North Carolina. Brigadier General Burch was deployed to Sarajevo, Bosnia-Herzegovina with Operation Joint Guard before leaving active duty in 1998, when she began her Army Reserve career with the 2<sup>nd</sup> Legal Support Organization (LSO), first in North Little Rock, Arkansas and then as Deputy Commander in New Orleans, Louisiana. She was mobilized with the 2<sup>nd</sup> LSO to III Corps and Fort Hood in 2004-2005, before her assignment as the Staff Judge Advocate, 4013<sup>th</sup> Garrison Support Unit in Bossier City, Louisiana. In 2008, she deployed to Kabul, Afghanistan with the Combined Security Transition Command-Afghanistan, as the Senior Mentor for the legal departments of the Afghan National Army and the Afghanistan Ministry of

Defense, in support of Operation Enduring Freedom. She was assigned as Commander, 22<sup>nd</sup> LSO, Grand Prairie, Texas, from October 2009-April 2012, when she began an assignment as the U.S. Army Reserve Legal Command Deputy Commanding Officer–West.

On July 16, 2012, following her selection for promotion to Brigadier General, she was assigned as the Chief Judge, Army Court of Criminal Appeals, U.S. Army Legal Services Agency (Individual Mobilization Augmentee) at Fort Belvoir, Virginia.

On May 14, 2013, Brigadier General Burch assumed Command of the United States Army Reserve Legal Command, in Gaithersburg, Maryland. Brigadier General Burch's awards include the Bronze Star and the Meritorious Service Medal (with 4 oak leaf clusters).

She is married and has two children.
