



**Chief Judge (IMA)

Ural D. Glanville**



Brigadier General Ural D. Glanville was born in Columbus, Ohio. In 1982, he enrolled at the University of Georgia (UGA) and joined the Army ROTC program. In 1984, he graduated from UGA and was commissioned as an Infantry 2LT, beginning his 29 years of military service. BG Glanville delayed his military service to attend law school at UGA. After completing his J.D., he served on active duty from 1990-1993. His active duty assignments include service with the U.S. Army Trial Defense Service and Trial Counsel for V Corps in Germany.

In 1993, BG Glanville returned to Atlanta, resuming his service with the Army Reserve in the 213th LOD. In the 213th, he served in several positions including Senior Legal Opinions Officer. In 1998, he was selected to serve as the Chief of Operational and Civil Law for the 2125th Garrison Support Unit (XVIII Airborne Corps). In 2000, he served as the Command Judge Advocate for the 359th Signal Brigade before being selected by The Judge Advocate General (TJAG) to serve as the Staff Judge Advocate (SJA) for the 335th Signal Command. As the 335th SJA, he deployed in support of OPERATION IRAQI FREEDOM. After his deployment, TJAG selected BG Glanville for command of the 213th LOD. Prior to being selected to be Chief Judge, Army Court of Criminal Appeals, BG Glanville was the Commanding General of the NATO Rule of Law Support Mission/Rule of Law Field Force-Afghanistan.

As a civilian, Judge Glanville has served as a prosecutor, criminal defense attorney and as a civil litigator. In 1996, he began his judicial service as a Magistrate Judge in Fulton County State Court. In 2004, after eight years as a

Magistrate, he became a Superior Court Judge in Fulton County, Georgia's busiest trial court of general jurisdiction. Judge Glanville's duties include trial of cases involving felony offenses, divorce, equity and cases regarding title to land. His responsibility also includes presiding over administrative appeals and jury trials.

BG Glanville's military education includes the Judge Advocate Basic and Advanced Courses, the Military Judge's Course, the Combined Armed Services and Staff School, the U.S. Army Command and General Staff College, the Staff Judge Advocate Course, the Law of War Course, the Operational Law Course, the Domestic Operational Law Course, the Ethics Counselors Course, the Legal Assistance Course, U.S. Army War College, the Advanced Joint Professional Military Education Program, an M.A. in Strategic Studies from the U.S. Army War College and Airborne School. BG Glanville's civilian education includes an A.A. from Brevard College, a B.A in History from UGA and a J.D. from UGA.

BG Glanville's awards include the Legion of Merit, the Bronze Star, the Meritorious Service Medal (with Oak Leaf Cluster), the Army Commendation Medal (with 3rd Oak Leaf Cluster), the Army Achievement Medal, the Army Reserve Components Achievement Medal (5th Award), the National Defense Service Medal (with 1 Bronze Service Star), the Global War on Terrorism Expeditionary Medal, the Global War on Terrorism Service Medal, Armed Forces Reserve Medal (with Silver Hourglass, "M" and Numeric "2" Devices), the Army Service Ribbon, the Overseas Service Ribbon, the Army Reserve Components Overseas Training Ribbon, the Meritorious Unit Commendation, and the Parachutist Badge. BG Glanville is married and has two children.
