Ms. Carlisle is responsible for the oversight of legal services provided to the Headquarters, Department of the Army through the Office of The Judge Advocate General and to the worldwide services provided to Soldiers and Family members. She supervises the Office of The Judge Advocate General's Legal Assistance Program, the Special Victims' Counsel Program, the Administrative Law Division, the Contract and Fiscal Law Action Division, the National Security Law Division, and the Criminal Law Division. She also serves as the Army Suspension and Debarment Official.

Prior to her current position, Ms. Carlisle served as the Director, Soldier and Family Legal Services. As a military officer, Ms. Carlisle served most recently as the Staff Judge Advocate for U.S. Army Africa/Southern European Task Force. Ms. Carlisle also served as the Chief, Administrative Law Division, Office of The Judge Advocate General and Staff Judge Advocate for 1st Armored Division and Fort Bliss.

Ms. Carlisle retired from the Army in 2019 with over 29 years of service. After being commissioned in 1990 through the ROTC program, she served as a military police officer before being selected for the Fully Funded Legal Education Program. After attending law school and joining the JAG Corps, she served in a variety of positions to include legal assistance attorney, administrative law attorney, chief of operational law, military personnel law attorney, and deputy staff judge advocate. Ms. Carlisle also served as the Deputy Staff Judge Advocate for U.S. Forces – Afghanistan.
