Brigadier General Paul S. Wilson assumed command as the Commanding General and Commandant, The Judge Advocate General's Legal Center and School, on 23 June 2016.

Brigadier General Wilson's military education includes the National War College, the Naval Command and Staff College, the Judge Advocate Officer Graduate Course, Combined Arms and Services Staff School, and the Judge Advocate Officer Basic Course.
