


## HOW TO ENROLL in an On-Site Course on JAG University

1. Go to JAG University at: <https://jagu.army.mil/>
2. Log in using either your CAC, or your AKO user name and password.

3. Upon logging in, you'll be taken to the JAGU homepage. Hover over the Enrollment tab and click on "On-Sites."



4. Find the GREAT LAKES On-Site and click on the title.

### FY 16 On-Site Legal Training (OSLT)

**Click the On-Site title below to self-enroll.**

**NOTE:** Each region's On-Site page will become available *approximately one month prior to the start date* of the On-Site. If you experience an enrollment error, please check back closer to that date.

For any enrollment questions, to include any required access codes, **contact your On-Site's Action Officer/ NCO.**

**ON-SITE 1. WESTERN:** L.A. AFB, Segundo, CA; 22-24 January 2016. Host: 78th LOD, 4 additional units attending (6th, 75th, 87th, 117th) and all Legal Administrators assigned to the DCO West.

**ON-SITE 2. SOUTHEAST:** FT Benning, GA; 19-21 February 2016. Host: 213th LOD, 4 additional units attending (2d, 12th, 134th, 174th) ) and all Legal Administrators assigned to DCO East.

**ON-SITE 3. MIDWEST:** National Guard PEC, Little Rock, AR; 18-20 March 2016. Host: 128th LOD, 3 additional units attending (1st, 8th, 214th) and SVC-WEST Supplemental Training Event.

**ON-SITE 4. NORTHEAST:** Naval Justice School, Newport, RI; 22-24 April 2016. Host: 7th LOD, 5 additional units attending (3rd, 4th, 10th, 151st, 153d) and the LC Change of Command

**ON-SITE 5. GREAT LAKES:** McGhee Tyson Air National Guard Base, Knoxville, TN; 10-12 June 2016. Host: 139th LOD, 2 additional units attending (9th, 91st) and SVC-EAST Supplemental Training Event.

**NOTE 1:** Soldiers of the 13th, 16th, 22nd, 150th, and 154th LODs may attend the on-site in their respective region.

5. At the next page, click SUBMIT to Self-Enroll.






