SUBJECT: Disestablishment of the Army Reserve Individual Mobilization Augmentation (IMA) Detachments

1. References:

- a. AR 140-1, Mission, Organization, and Training, 20 January 2004.
- b. AR 140-145, Individual Mobilization Augmentation (IMA) Program, 22 April 2007 with rapid revision, 17 July 2012.

2. Effective 30 September 2013, all existing IMA Detachments are disestablished.

3. Similar to Reinforcement Training Units (RTU), IMA Detachments were designed to support the organizational missions of proponent organizations during the Cold War era in a "points only" status. The Chief, United States Army Reserve, has determined that RTUs do not meet the Army transformation criteria and has ordered all RTUs disestablished effective 21 September 2013. Resultant, in support of this HRC will also disestablish all IMA Detachments.

4. This action does not eliminate the capability for Reserve Component Soldiers to serve for points only credit. The authorization for RC Soldiers to receive retirement points for service remains in effect, but requires that they be attached to an Army agency before credit can be given.

5. HRC will make every effort to support the Soldiers being removed from IMA Detachments by offering them transition opportunities that will allow them to continue to serve in the IMA/DIMA (Drilling Individual Mobilization Augmentee) program or a Reserve Component unit. All IMA positions are now considered DIMA (except general officer authorizations) and Soldiers are authorized up to 48 4-hour periods of Inactive Duty Training (IDT) for pay annually.

6. The following actions will occur no later than the effective date:

- a. HRC will publish permanent orders disestablishing the remaining IMA detachments.

- b. HRC will release all unit personnel from their IMA Detachment attachment



no later than 30 September 2013 and offer other opportunities for points only or paid status service.

c. HRC will cease attaching new personnel to IMA Detachments effective the date of this memorandum.

d. IMA Detachment Commanders will turn in any government property issued in support of the IMA Detachment IAW applicable Army Regulations.
